Citizens Speak

Terry Burke Dotson of 20 Salo Ter asked for more information about the Chain of Lights and asked to keep the Senior Center open until 4:30pm during the event.

Chain of Lights-Heather Trudell of Keenan & Trudell

Heather Trudell and Lynn Feiz presented the Chain of Lights. Heather stated the 24th Annual Millbury Chain of Lights will take place on 12/3 from 10:30am to 4:30pm. The trollies will be available for transportation. This year there will be 40 stops. Santa and Mrs. Claus will be at the Mansion, Hayrides at Bank Hometown, Gingerbread man decorating at the Senior Center, Gingerbread house contest at the Cake Shop cafe, carolers will be walking around town, Buddy the Elf and Frosty the Snowman and the Grinch will be present, Balloon artist at the Felter's Mill, and Vinny the Bubble Guy at the Town Commons, Kim Webster will be at the Senior Center performing a puppet show, and the library will have events as well. A local musician and vendors will be available. Lynn Feiz shared the history of the Chain of Lights. The event will allow businesses and families to enjoy together. Over the years the event has grown exponentially. Lynn and Heather plan to step down from the Chain of Lights committee. They are hoping that other volunteers will step up and they will guide the newcomers with the process. They thanked all the businesses and sponsors for their work. The Board thanked them both for their great work!

Citizen Speak continued

Fran Desimone of 1 Weldon Dr stated that on 11/29 there is a ZBA meeting and the Board should attend it as town residents regarding the LIP agreement and brought up the Attorney Generals decision regarding an article. Chairman Naff stated the Town can appeal the AG's decision, he is discussing options with the Town Counsel, appealing it to court would be expensive and our chances of winning are low.

Stormwater Enterprise Account-Jaurice Schwartz of Weston & Sampson

Chairman Naff stated it comes down to the implementation of new fees. Jaurice stated she has presented to the Board previously. Karyn Clark, Julie VanArsdalen, Keith Caruso, Mark Hollis and Conor McCormack created a group to address the Stormwater system. The Group has worked on Stormwater system related topics. The MS4 is the Municipal Separate Storm Sewer System. Millbury's system is 34 miles of drain pipes and outfalls. The permit has a 5 year cycle, the new permit needs to be renewed. The intent is to improve water quality and control pollutant

discharge. More permit requirements equals more money. There are 6 control measures on the permit. In order to meet requirements, the Town did take out a loan and it will need to be paid back. Other stormwater needs are flooding, frequency of storm events, failing infrastructure and overall maintenance. The payback process would be through the state revolving fund loan. Future funding options can be through increasing taxes, loans, partnerships and grants and the Stormwater enterprise fund. This fund is reliable and it is a fee collected by property owners depending on the properties impact on the stormwater system. Jaurice shared the general fees in Massachusetts such as small residential, other and non residential fees, tiered fees and collected revenues. The Group discussed different structures and rates for Millbury residents. The next step would be to adopt a rate and create a Stormwater commission. Fees can be collected July 1st and a bylaw could be created to enforce the fee.

The Board discussed if they want to implement the fee and what the fee structure would be. Jennifer Barrett stated the cost distribution is the main topic of discussion regarding the fee. The Board discussed a fair way for residents to pay the fee.
