Agent Flynn recommended the Board grant the 2-year extension. Mathew Ashmankas made the motion to grant the extension, Jeffrey Raymond seconded the motion voted, all in favor, carried unanimously, Extension Granted.

Mathew Ashmankas made a statement that he is concerned that the proponent does not have 50% of upland to make it a buildable lot Agent Flynn agreed with Mr. Ashmankas and stated he is concerned with the wetland delineation and not having enough upland. Agent Flynn stated he visited the site, performed soil sampling but did not have the full delineation data. The proponent asked for a continuance. Paul DiCicco made a motion to continue, Jeffrey Raymond seconded, all in favor, carried unanimously.
