Old Business:

DEP # 224-0860 NOI Continuance 142 Riverlin St.:

Norman Hill from Land Planning spoke on behalf of the project. He stated that he had spoken to the proponent about the project a few days ago and has not heard back from him. Mr. Hill asked to continue to the next meeting March 20, 2024. Mathew Ashmankas made a motion to continue to March 20, 2024, Jeffrey Raymond seconded the motion, and voted unanimously.

DEP#224-0861- 6 McGrath Rd., NOI Continuance.

Michael Hassett from Guerriere & Halnon, Inc.representing the applicant proposing a single-family home on 6 McGrath Rd. stated all work will occur in the buffer zone. In that last meeting everything had been wrapped up and were just waiting for DEP to assign a filing number. Mr. Hassett continued that the DEP had a couple comments, that Erosion controls are to encompass the work area and, that the Commission may want to consider including a perpetual condition in their Order of Conditions, if approved, requiring permanent memorialization fixtures such as a split rail fence, landscaping boulders, and/or signage to prevent future encroachment beyond the approved limit of work. Mr. Hassett stated that an erosion and sedimentation control barrier is shown on the submitted plan to fully encompass the proposed work area. Agent Flynn addressed the Commission stating that he had drafted Special Orders of Conditions that required installation of Wetland designation signage at three wetland flagged locations. Mr. Hassett agreed to the proposed sign locations. Paul DiCicco made a motion to close the hearing, Christopher Weagle seconded the motion, and voted unanimously. Jeffrey Raymond made a motion to approve the project, Mathew Ashmankas seconded the motion, and voted unanimously.

New Business:

58 Davis Rd. Certificate of Compliance:

Chairman Stead opened the public meeting. Mr. Stead then stated that the proponent needs to close the outstanding OOC MADEP #224-0755 with a Certificate of Compliance before we can issue a new Order of Conditions for recording. Jeffrey Raymond made a motion to issue the COC, Paul DiCicco seconded, voted 4 in favor to Issue the COC with Christopher Weagle voting no. The COC will be issued upon signing.

58 Davis Rd NOI:

Kate O'Donnell from Eco Tec spoke on behalf of the project. She stated that they came before the board back in November to complete the work under enforcement order. They are now coming to the commission with a new Notice of Intent to restore the filled area within the wetland and the 15 ft of Buffer zone under their submitted Restoration Protocol on 58 Davis Rd and the Boria Property. MS. O'Donnell stated they are proposing a lawn expansion project and removal of fill and replace with natural sapling and shrubs.

Scott Koneczny proposed a fire pit outside the 15-foot buffer zone and has agreed to pull back the scrap metal to an area agreed upon in the field with the Boria's, and Mr. Koneczny will take out part of the fill that is in the wetlands and will pull some stones out of the channel.

Agent Flynn feels they are making great headway, so he asked for a larger set of plans. The new elevations don't match up with the old elevations. Agent Flynn asked for a modification to the written plan that Mr. Koneczny willingness to move the shed, move stone under the bridge making the best effort. Mr. Flynn feels if the removal of the buffer would be adequate, so the water could spread out and pool instead of being funneled.

Mathew Ashmankas made a motion to continue the meeting until 4/3/2024, Jeffrey Raymond seconded the motion. Voted unanimously to continue to April 3, 2024, meeting.
