Discussion of safety concerns at intersection of Millbury Ave and Howe Ave-Update from TEC

Kevin Dandrade from TEC updated the Board about Millbury Ave and Howe Ave. The issue was traffic control and direction. He offered solutions such as a Stop control on Howe Ave or a Stop control on Millbury Ave, curbing, ADA ramps. The project cost would be around \$500,000. Chairman Naff thanked Kevin and asked questions regarding the proposed design. Selectman Despres asked how would you take a left onto Howe Ave? Kevin stated you would require the traffic to stop and then turn onto the side street. Selectman Krumsiek and Selectman Sora brought up the collisions that recently occurred at the intersection. Kevin stated the design would slow speeds and traffic patterns. Keith Caruso stated Chp.90 would cover the expenses of the project for the first year. The Board discussed the proposed project, past accidents and identified funding resources.

Management Update

Karyn stated the current FHQ is all set with inspections and constructions, the Board will be able to make a final decision on the property shortly. Selectman Despres stated Downtown Improvement looks great, he noticed some missing signals/signage. Karyn said she will check
